

THE TAU CETI CON GAME

On Sunday night July 30, Art Bell host of the Coast to Coast AM radio show interviewed Dr. Steven Greer director of the Disclosure Project.

During the interview Bell asked Dr. Greer to verify statements he made publicly about the SETI Institute having in their possession records of numerous messages that they received from at least one extraterrestrial civilization. Dr. Greer in response stated that he did in fact make the statement and strongly stood by it. Dr. Greer went further during the interview with Bell and related that the source of his information came from a person within the SETI institute itself.

On Tuesday August 1, 2006 on the Coast to Coast Am program hosted by George Noory the Senior Astronomer at SETI Seth Shostak stated that Dr. Greer was totally wrong about his organization having received any extraterrestrial radio messages.

Shostak claimed that if SETI had receive any ET message they would immediately inform other astronomers of the event so that they could focus their equipment on the the same area of the sky and verify the message to be a fact.

At this point I ask: What if such an Extraterrestrial radio message was not transmitted from a solar system many light years distant from Earth, but was transmitted from a Extraterrestrial spacecraft located within our solar system, or from our moon?

Mr. Shostak and his organization don't even want to consider this possibility, or have you the reader consider it. Why? Because if this was so then their years of putting down the fact that UFOs are actually visiting extraterrestrial spacecraft would have been for naught. Something moving at several thousand miles per hour would be hard to focus a radio telescope on.

George Noory repeatedly said during his interview that in his opinion Dr. Greer and Seth Shostak were both upright fellows.

The bottom-line questions here are: Have any extraterrestrial radio messages been received by anyone on the Earth, and is there any hard evidence that proves this to be true, and further more is the SETI Institute completely unaware of this fact ?

We of the Ra Research Society here by publicly state that we believe without any reservation or doubt that nine extraterrestrial radio messages werer received and recorded on the Earth prior to January 31, 1995.

In the fall of 1997 I received an e-mail from my niece Cindia Achcetson that contained what was supposedly nine fictitious ET radio messages that were posted on the internet as an “experiment” by a Group calling itself the “Contact Project” (C.P.). Cindia said that she found the Contact Project’s web site by clicking on a link she found on the official web site of the *SETI Institute*. I later confirmed this link.

The person who controlled the P.C. web site named David Levine said he was conducting the “experiment” in order to determine how we might translate any real ET messages we might receive in the future.

The Contact Project- Why?

“Why are we doing this? What is it all about? Well obviously, no messages have really been received from Tau Ceti. However, I urge you to leave reality behind for a little while, and help us try to understand the message. This should be a lot of fun for all involved, and I hope it will show us just how far we have to go before we will be able to understand any real messages we receive. There have been projects like this before. However, they have always been (in my opinion) fairly simple tests, being very anthropomorphic in nature. What I hope I have achieved (sic) here is something different. books on cryptography... anything. Just remember to share what you are doing and what you are thinking with all of us.

Through a lot of time and effort a message has been developed that is fairly simple in content, but very unusual in the way it is put together. It should be very difficult to understand the way the message is written, even if you understand its contents. In fact, there are ways it could be made even more ...alien... but then I don't think anyone would get it. As it is, I predict it will take a few weeks anyway.

Then there's the other thing that differentiates this project from earlier ones: you. Anyone can participate, and I hope anyone does. You can try anything you like to decode the the message... write computer programs, show the message to your friends, use books on cryptography... anything. Just remember to share what you are doing and what you are thinking with all of us.

Use the Discussion Page! This should be an interactive group project involving people from around the planet. With the talent out there, it should be possible to solve the first message.

Yes, I did say first message. There will soon follow others. Over time, we will hopefully learn a good deal about the denizens of the Tau Ceti system. Of course, that all depends on you.”

The first message and the headings for messages two and three are presented next:

The original message consisted of 571 "characters," a long pause of 17.71 seconds, then a repeat of the sequence.

The characters are here arranged by pitch. There were 19 unique tones in the original message, here labeled A through S. A is the lowest tone, and S is the highest. Each tone lasts about 0.492 seconds. The entire sequence, including pause, took 298.61 seconds, or about 4 minutes and 59 seconds. The message is being broadcast on a wavelength of 21 cm, the so-called "magic frequency."

In the second message, there are 18 new characters, for a total of 37 characters used so far. The new characters are represented by the letters "T" through "Z" and "a" through "k". T is higher in pitch than S, and so on. This message is 874 characters long. Again, each tone takes 0.492 seconds, and the pause is 17.71 seconds between repetitions. The message length is 447.67 seconds, or 7 minutes and 28 seconds.

The third message is the longest so far with 1514 tones for a message length of 12 minutes, 42.5 seconds (762.5 seconds). Again, each tone is the standard length, as is the pause. We should come up with names for these time units. There are 25 new characters, for a total of 62 used so far.

Note: No small L (l), thus there are only 24 new tones in this message and only 61 used so far. W.H.B.

It is obvious that whoever really assigned the symbols (letters) to the various message tones realized that the small case L (l) was identical to the capital i (I) and eliminated the small L (l) to avoid confusion. Don't you think, if David Levine (who claims to have made up these messages) would have realized how these identical letters would have confused his "game players" and would have told them, instead of letting them think that the small L (l) was introduced in message 3? We believe that David Levine got these messages from some well focused individual or organization who at least respected accuracy.

The nine messages laid on my desk for weeks. I did not feel I wanted to take the time or make the effort to play a "game."

Then a statement found in the heading of message 2 caught my attention, it says: " In the second message, there are 18 new characters, for a total of 37 characters used so far."

As many of the readers know, I have researched the dimensions and geometry of the Great Pyramid of Giza for about forty years and that during my studies I rediscovered a natural system of mathematics that was used by the designer to create the structure. I called this system the Ra System and the units of measure that were derived from it “The Rods of Amon Ra” after the ancient Egyptian sun god “Amon Ra.”

In the Ra System exists a group of 37 numbers which are collectively referred to as the Ra Table of Nines (t.o.n.).

Each number in the Ra Table of Nines added horizontally will always total 9. Each are also multiples of the number 9 ($3 \times 9 = 27$ --- $6 \times 9 = 54$... ect.).

It occurred to me that the message tones symbolized by the Contact project “A” to “k” in ET messages 1 and 2 might also be viewed numerically as “A” = 27, “B” = 54, “C” = 81 and so on.

Message 1 contains 46 sections, These sections are separated (bracketed) by the letter “G.” In the interest of brevity, only the first 7 sections of this message are reproduced below.

Original Message (30-Jan-95):

The “G” symbols have been found to be neutral so, the first section of the message GBG should be looked at as G 54 G.

The Contact Project said that each tone had a duration of “about .492 seconds +/- 5%.” *If this were a game why not say exactly .492 seconds?*

I simply divided the active value of 54 as found in section 1 by .492 (tone time duration) and got 109.756097561 as an answer. I recognized this number to be a close approximation to a number well know in atomic physics as the “Rydberg Constant for Infinite Mass.” It is used in simple equations that give us the wavelengths of the spectral lines of the element hydrogen, from the infra red to the ultra violet.

The Ra value for the Rydberg Constant is: 109,739369, so the real duration of the ET tone time unit is: .492075 seconds or .000075 seconds longer than what was reported by the Contact Project.

It was found that the Extraterrestrials really used one tone time unit in their messages, but they divided it into different increments. These increments are .492075 parts of a “natural second of time” and .493827160 parts of a natural second of time (n.s.t). The pause (silence) that exists between the repeat of a particular message is respectively 36 times either of the

incremented units, or respectively 17.777777--- parts of a natural second or 17.7147 parts of a natural second.

It was also realized that each tone of an ET message should be looked at as having 3 levels of value.

That is: A=27-9-3 ... B=54-18-6 ... C= 81-27-9 ... D=108 -36-12 .

Looking at GBG (message 1, section 1) in its 3 level values of 6-18-54 and dividing each of these values by ET tone duration 1 which is .493827160 parts of a natural second we get a number of astonishing results.

Level 1: $6 \div .493827160 = 12.15$ There are 121.5 Ra millimicrons in the Lyman m2 spectral line of hydrogen (an ultra violet line and also the most intense line produce by the element).

Level 2: $18 \div .493827160 = 36.45$. Written as 364.5 this value is another constant used in equations to mathematically determine the visible spectral lines of hydrogen , it is called the Balmer Constant.

Level 3: $54 \div .493827160 = 109.35$. Written as 1093.5 millimicrons this value is the wavelength of the Paschen m6 spectral line of hydrogen, which is in the infra red range of the spectrum.

The decimal point in the above results would be in the right place if the Extraterrestrials had used .043827160 parts of a natural second in the timing of their tones, but probably knew such a time unit would be too brief for us to measure.

It is very obvious that the Extraterrestrials want to tell us something, we do not yet know about the element hydrogen.

By the way, section 2 of ET message one (GBBG) describes a square in the following way: $G \ 54 \times 54 \ G = 2,916$ square units. Did you know that there are 29160 cubic centimeters (centimeters) in the ancient Egyptian unit of measure called the “artaba.” This can be verified on the internet.

Additionally I think you should know, that the radius of either of the 3 outlying circles in the Barbury Castle Crop Formation of July 1991 (in England) has a length of 41.00625 Ra feet and that there are 410.0625 millimicrons in the Balmer m6 spectral line of hydrogen.

After a number of requests from one of his “game players” for the frequency of his “fictitious tones” David Levine posted the following on his web site:

And so on. Each tone is about 12.1965 Hz higher in freq. than the prev. tone.

Ra team: Note C.P. gives us the first 2 clues to their deception in revealing the frequencies, for what they say are tones “D” and “E”.

C.P. tone “D” or 109.768 is actually 109.739369 Ra hz. (track 1) This is the Ra value for the “Rydberg Constant for infinite mass.”

109.739369 Ra Hz is actually 9 x the frequency increment of 12.193263222 Ra Hz (Tone “E” frequency track 1).

The tone “E” frequency or 121.965 Hz. is also actually 121.5 Ra Hz. (track 2) This is the wave length of the most intense spectral line of hydrogen (Lyman m2- ultra violet).

Imagine the odds against anyone (even a genius) coming up with the Rydberg Constant and the wavelength of the Lyman m2 spectral line of hydrogen as tone frequencies, in what they say are 9 “fictitious ET messages .”

The next clue to the Contact Project (David Levine’s) deception is found in the following quote which pertains to the basic tone frequency:

VERY IMPORTANT DATA

The Ra value for this frequency was easily determined to be 12.193263222 Hz per natural second of time (n.s.t.) in track 1 units.

The reciprocal of 12.193263222 $(1/x) = .0820125$. This result written as: 8.20125×10^{-17} erg/seconds this value is equal to the energy obtained from the mass of an electron, as per the

equation $E = M C^2$. This is based on the facts that the mass of the electron is 9.1125×10^{-28} grams (omega left 1 up units) and the Ra speed of light is 300,000 kilorams per n.s.t. .

One half of 820.125 is 410.0625 and viewed as milli micron units this value is the wave length of the Balmer m6 spectral line of hydrogen.

The nine Extraterrestrial messages, Ancient Egypt, and a great many crop formations (those which were ET created) certainly have the Ra System of Mathematics in common.

When David Levine of Project Contact shut down his web site he told his loyal game players that the messages had been interpreted and “told an alien story of creation” which took place on a planet that orbited the star Tau Ceti. He said this story began with “bugs and worms crawling about on the slime covered surface” of his fictitious world. He never said how the 81 tones that composed the 9 messages told this ridiculous story. Because of this attempt by David Levine and the Contact Project to deceive the public, we have named this nonsense the “Tau Ceti Con Game.”

By the way, did you see any sign of David Levine’s bugs and worms in the information given above? Anyone who still believes David Levine made up these messages has my deepest sympathy. If you want a laugh look at his archived discussion page at: www.ibiblio.org/lunar/alien.html.

Subject: Is this a conspiracy, or does it simply look that way?

Dear Mr. Bell:

At the request of Wesley H. Bateman, on April 27, 2004 I personally delivered a package to Colm A. Kelleher, Ph.D., Administrator of Space Sciences, Inc. It contained information that I had told him was the smoking gun that the National Institute for Discovery Science (NIDS) had been looking for. Smoking gun was a term used by Dr. Kelleher when being interviewed by you on Coast-to-Coast AM, and it directly referred to locating hard evidence proving that extraterrestrials exist.

The information that I delivered to Dr. Kelleher revolved around nine ET messages that were posted as a game on David Levine's Website, and linked from the SETI Website. The said messages were received via radio telescope on the 1420 MHz frequency prior to January 31, 1995. Wes believes, based upon good information, that the messages were actually received two years earlier.

The history behind Wes' ability to solve these messages goes back to 1975. At that time Wes rediscovered an ancient system of mathematics known today as the "RA System of Mathematics." By some stroke of coincidence, maybe, in 1997 he found that the RA System of Mathematics was directly linked to the nine ET messages posted on Levine's Website. The information that he and his team have discovered since then while working on these messages, in Wes' words, is mind

blowing. I happen to agree.

The data that I had delivered to Dr. Kelleher must have been of great interest to him, because he requested more on several different occasions. But in each case he was provided with only enough information to feed his curiosity ... not the nuts and bolts that he was looking for. He did his absolute best to get all the research behind the smoking gun data, with no strings attached. He even went so far as to voluntarily write a Non-Disclosure Agreement on behalf of NIDS, which he signed and faxed to me on June 10, 2004. Mr. Bateman had several matters he had to take into consideration. One, a non-disclosure agreement, no matter how well written, is only as good as your pockets are deep, and Mr. Bigelow's pockets were very deep. And number two, NIDS's actions had been much less than forthright up to that point, not to mention the fact that there were volumes of unknowns regarding NIDS. The risk was far too great, and he rejected the offer.

On more than one occasion, I personally delivered the additional information requested by Dr. Kelleher, and each time that we met he seemed to make a point of emphasizing the fact that Space Sciences, Inc. and NIDS were far too busy to get involved in another project.

On July 22nd Dr. Kelleher sent an email to Wes and me stating:

"I will continue to pursue due diligence so that I can ascertain the origin of these intriguing messages. Needless to mention, I do not doubt in the least anything you have told me. Simultaneously, NIDS is also pursuing a separate cryptanalysis investigative track on these messages. I will keep you apprised regarding my progress, but I cannot give you an exact date when my due diligence will be complete."

There is another piece of important information that I need to share with you that goes back to April. Shortly after my first meeting with Dr Kelleher, during which I personally delivered the smoking gun data, Dr. Bruce Cornet, Deputy Director of NIDS, contacted Wesley Bateman (he went around NIDS to do so) concerning a UFO that he had captured on film using a camcorder. He told Wes that in 1997 he was driven by reasons unknown to him, to go to a specific location, on a specific date, with an assistant and a camcorder. They weren't at the location for very long before a UFO made a pass over him. When all was said and done, the UFO had made several passes. Each time it made a pass at him, its lights were flashing, and the sequence of the flashing lights was different each time. When Dr. Cornet made contact with Wes, the information that he sent included a study that he had conducted on the timing and sequence of the flashing lights. Within days after making contact with Mr. Bateman, Dr. Cornet was fired.

Wes applied the RA System of Mathematics to the data sent by Dr. Cornet, and discovered that the messages conveyed by the flashing lights were mathematically linked to the nine ET messages received in 1995. Was it simply a coincidence that the flashing lights were directly linked to the nine ET messages posted on David Levine's Website, or was it by design?

Going back to April once again, when Dr. Kelleher and I met, I told him that Mr. Bigelow's organization had been contacted for two reasons. One, Wes and his team needed additional people, as well as financial resources to speed up the process to solve the ET messages. And two, Robert Bigelow had enough personal financial resources that greed should not become a factor. It is Wes Bateman's position that these messages are meant for everyone. He and his colleagues have invested an enormous amount of time and money since 1975 to research and learn the Ra System of Mathematics, which has been integral to

solving the nine ET messages. He does not want any individual or organization to take credit for the discovery of the information contained in the messages, nor the system of mathematics required to solve them. But most of all, he does not want any individual or organization to take control of any technology that may be found in those messages, strictly for their personal financial gain. We made it clear to Dr. Kelleher that any technology derived from the messages would belong to the people of the world as a benefit to all mankind. That was not acceptable, and they did their best to get around it.

What is most interesting about all of this is the fact that NIDS has recently closed their doors, and following is part of the statement they provided: " We have not had the need to do any major investigative work for well over 2? years."

I find that statement VERY interesting, especially when I take into consideration Dr. Colm Kelleher's statement ... we're far too busy to take on any other projects. Wes and I believe that they found their smoking gun in the data that I delivered to Dr. Kelleher, and NIDS has gone underground to work on it.

There is one final piece of interesting information. Shortly after the 11:30 AM meeting with Dr. Kelleher, on April 27th, at Space Sciences, Inc, in Las Vegas, Nevada, I wrote an article titled, "Time Lost - Continued". The article contained information regarding my meeting with Dr. Kelleher, plus the events that led up to it. On July 20th, Dr. Kelleher sent me an email demanding that I remove the Space Sciences, Inc. name from the article. The article was, and still is posted on several websites, without any changes.

I have often wondered what motivated Dr. Kelleher's demand to remove Space Sciences, Inc.'s name from my article.

In conclusion, Wes Bateman and I would welcome an opportunity to share with you and your audience some very

thought provoking information.

Note: Art Bell never responded to this letter. Perhaps it is because Art Bell claims that Robert Bigello is a friend of his?

It is quite clear to me and the Ra research team that Mr. Levine had absolutely no knowledge of the Ra System of Mathematics, and was just as ignorant of the content of the messages as were those he attempted to con into translating them for him, or anyone he was fronting for.

We definitely believe that David Levine was first chosen by another person or organization to interpret the ET messages that they in some way received. He was probably chosen for the task because of his expertise in the area of computer programming. Interesting enough is the fact, that there are several David Levines with different middle initials that are known to be interested in the “field of computer game design.” The David Levine who created the “Contact Project” never used his middle initial, so it is difficult to accurately identify which one he really is. Maybe he isn’t any of these people, or maybe he is all of them.

One of these Levines once contracted for NASA to work on a project called “Aquarius,” and later to write computer programs for the International Space Station.

Presently a person named David M Levine is first at the top of our list of possible candidates who could have been the front

man for the Tau Ceti Con Game.

It is quite obvious to us that whichever David Levine was involved in the “Tau Ceti Con Game”, didn’t know the slightest thing about the Ra System and was also totally unable to decode the messages with his computer expertise.

He must have concluded that he could not really begin such a project, until he first had an inkling as to how the messages were written. This is why he emphasized to his game players to concentrate on “how the messages were written and not on what they actually said.”

Failing with all his knowledge to determine how the messages were written Levine could not proceed to use any kind of known cryptanalysis program to extract any data from the unique series of 81 tones that compose the messages. Thus the idea occurred to him (or someone else) to seek help in solving his problem by inventing the Tau Ceti Con Game. Note: Levine told his game players that the 9 messages were composed of “82 tones.” Don’t you think the brilliant inventor of the so-called “fictitious messages” would remember that he only used 81 tones to compose the messages? Of course he would. This error certainly gives us a solid clue to the fact that David Levine did not write these messages.

The National Institute of Discovery Science (NIDS) employed two retired government “code breakers” to use cryptanalysis programs on the messages. NIDS reported to us that these experts failed in their efforts. NIDS recently suspended their public activities. For many years wealthy businessman, Robert Bigelow funded this organization.

It is also interesting to note that after our initial contact with NIDS we learned that a key contractor for NASA's "Project Aquarius" was the "Bigelow Oceanic Laboratory" (located in New England). Remember a Dr. David Levine was deputy director of this NASA project. Is this a coincidence, or did NIDS realize that their association with us amounted to a conflict of interest?

In our opinion there is a very remote possibility that the SETI Institute has not heard of the Nine ET Messages of which we speak. It will be interesting to see how they publically will deal with this information.

We predict that they will stop at nothing to squelch it.

If they do such a thing, inturn we will respond by presenting more and more translated ET message data. Why should they mind? Its only a game. Isn't it?
